## Terms of Service

Effective Date: April 20, 2026

### 1. Acceptance of Terms

These Terms of Service ("Terms") govern your use of the WoofWoof messenger ("App", "Service"). By installing and using the App, you confirm that you have read, understood, and agree to these Terms. If you do not agree, please do not use the App.

### 2. Service Description

WoofWoof is an end-to-end encrypted messenger providing:

- Text messaging
- Voice calls
- Video calls

Text messages are protected by end-to-end encryption (E2E). Voice and video calls are transmitted via WebRTC and protected by the standard DTLS-SRTP encryption protocol. The Service is provided "as is".

### 3. Account Registration

To use the App, you must:

- Choose a pseudonym (username). We do not require your real name, phone number, or email.
- You are responsible for maintaining the security of your account credentials.
- You may not create accounts impersonating real individuals to mislead other users.

### 4. Acceptable Use

#### 4.1. Prohibited Uses

You may not use the App to:

- Share illegal content (child exploitation material, incitement to violence, terrorist activity).

- Harass, threaten, intimidate, or stalk other users.
- Engage in fraud, phishing, or other deceptive practices.
- Distribute malicious software.
- Violate any applicable laws or regulations.

## **4.2. Content Responsibility**

Since all messages are encrypted and inaccessible to us, you bear full responsibility for the content you transmit through the App. We do not and cannot moderate encrypted communications.

## **5. Intellectual Property**

All rights to the App, including its design, logo, and source code, belong to the WoofWoof developers. You receive a limited, non-exclusive, non-transferable license to use the App for personal, non-commercial purposes.

## **6. Privacy**

Data processing is carried out in accordance with the WoofWoof Privacy Policy, which forms an integral part of these Terms.

## **7. Limitation of Liability**

WoofWoof is provided "as is" without any warranties. We are not liable for:

- Service interruptions or downtime.
- Data loss due to technical failures.
- Actions of third parties who gain unauthorized access to a user's account.
- Any damages arising from the use or inability to use the App.

## **8. Account Termination**

We reserve the right to suspend or delete accounts that violate these Terms. You may delete your account at any time through the App settings.

## **9. Changes to Terms**

We may update these Terms. We will notify you of significant changes through the App interface. Continued use of the App after changes indicates your acceptance of the updated Terms.

## **10. Governing Law**

These Terms are governed by applicable law. Disputes shall be resolved through negotiation, and if unresolved, in accordance with applicable legal procedures.
